**ORDER**

**NO.SO/II/8-1(04)/2020 (Stage-3 NPIs):** In pursuance of the decisions at NCOC forum and communicated vide letters (i) No.801/A/ NCOC-01 dated 22.03.2021 and No.801/A/NCOC-01 dated 29.03.2021, the Government of Sindh in exercise of the powers under Section 3 (1) of Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) is pleased to re-direct as under with immediate effect and till **11<sup>th</sup> April, 2021**, unless changed or amended earlier:-

- a) **Broader lockdowns (BLDs)** in areas with more than 8% positivity with stringent enforcement protocols based on risk assessment and no mobility except emergency on disease hotspots by respective Commissioners and Deputy Commissioners under Sindh Epidemic Diseases Act 2014.
  - b) **Restaurants – No indoor dining.** Outdoor dining till 10:00 PM and thereafter only takeaway / home delivery.
  - c) **All commercial / business timings** e.g. Markets, Shopping Malls, Marriage Halls, etc **from 06:00 to 20:00 hours** with two safe days observance per week as applicable to that area concerned (except essential services i.e. Medical Stores, Clinics, Hospitals as well as Petrol Pumps, Bakeries / Milk Shops, Restaurants etc).
  - d) All Kind of gatherings (indoor as well as outdoor) including social, cultural, political, sports, musical / religious, festivals or miscellaneous events are completely banned.
  - e) Complete closure of Cinemas and Shrines
  - f) Marriage functions only outdoor with limited number/close family members as per earlier order dated 15<sup>th</sup> March, 2021 till 05<sup>th</sup> April, 2021.
  - g) **Complete Ban on marriage functions indoor and outdoor w.e.f 06<sup>th</sup> April, 2021.**
  - h) Complete closure of Amusement Parks -, Walking / jogging tracks will remain open with strict adherence Covid-19 SOPs
  - i) **Work from Home** - 50% of the staff in all public / private sector offices and Courts.
  - j) Reduced presence at Courts (City, District, High Courts and Supreme Court)
  - k) Intercity Public Transport to operate at 50% of Capacity with strict SOPs compliance.
  - l) **Compulsory Mask wearing and Social Distance** - at all Government / private offices and Public places.
2. Disease spread will be reviewed further on 07<sup>th</sup> April 2021 at NCOC forum for any further required actions.
3. The SOPs issued vide Home Department, Government of Sindh Order NO.SO(Jud-I)/HD/8-1(04)/2020-Corona/SOPs dated 06.11.2020 strictly to be complied.
