

EFP-EOBI HELP DESK REVIVAL

This is to inform our members that EFP team comprising of Mr. Zaki Ahmed Khan, Syed Nazar Ali and Mr. Fasihul Karim Siddiqi met Chairman EOBI in his office on 15th February 2022 and discussed issues and challenges currently being faced by Employers with a view to revive the bilateral spirit and to find their short-and long-term solutions.

It was resolved that the EFP-EOBI facilitation Help Desk will be revived at the EFP Secretariat to help employers in resolving issues relating to EOBI. Pursuant to the discussion with EOBI:

- a. Employers registered with EFP paying contribution at the rate of Rs.8000/- or less are requested to pay contribution at the rate of Rs.13,000/- in order to get higher pension for their retiring workers as per formula specified in EOB Act, 1976.
- b. The backlog payment can be made in easy installments spread over a period of 12 months. EOBI has been requested that the help desk may assist employers in this matter on case-to-case basis. These employers are also requested to pay contribution at the rate of Rs.13,000/- in the interest of both employers and their workers.
- c. The payment of arrears by petitioner employers on account of difference between Rs.8,000/- and 13,000/- with effect from 1st July, 2013 to December 2021 will be subject to final outcome of cases before the Supreme Court of Pakistan.
- d. EOBI has been requested to act according to law while conducting employers' audit.
- e. The EOBI will facilitate all the employers to generate vouchers & pay contribution through EOBI portal.
- f. Notices sent to enterprises in Punjab and KPK for payment of contribution at enhanced rate will be reviewed by EOBI on receipt of written application on case to case basis, as per applicable law and in terms of judgments of High Courts. However, these companies will be requested to pay contribution @ Rs. 13,000/p.m. and these payments will be subject to final outcome of cases before the legal fora.
