Participation Criteria

Evaluation will be based on a self-declared response to a standardized questionnaire, which will be verified by an Evaluation Committee

Detailed Questionnaire:

Provide specific information about the policies, initiatives, and accomplishments in OSH.

Supporting Documents:

Attempt all questions and provide supporting information/documentation as evidence

On-site Verification:

Contestants may also receive a follow-up call or an on-site verification visit with prior notification.

Sector Categorization for Award

Same as last year, companies will be evaluated and awarded based on their sector. The sector categories are:

- Textiles, Leather, and Sports
- Oil, Gas, and Mining
- Power and Energy
- Chemical, Petrochemical, and Allied Industries
- Food and FMCG
- Healthcare and Pharmaceuticals
- Banks, IT, and Financial Institutions
- Transport and Logistics
- Engineering, Automotive, and Components
- Other Sectors
